PRIVACY POLICY

June 20th, 2022

For InBattle VR, your privacy is very important, and we take it seriously. Please read this Privacy Policy, that applies to users of all our related services: Free Roam VR services, website, app, booking services, player account, In Battle community.

By using our services, you are accepting and providing your consent to the practices and policies regarding collection, use and share of your information detailed in this document.

This Privacy Policy covers the treatment of your Personal Data (personal information that identifies a particular individual), gathered when you use any of our services. Please note that we only ask your personal information in order to provide you with the services you request, including booking and playing one of our games.

This Privacy Policy does not cover the practices of companies we don't own or control or people we don't manage.

PERSONAL DATA COLLECTION:

We can get or receive your information through different categories:

- Voluntarily provided: Personal information provided by you to book, play, or complete your account and game profile, such as first and last name, email, phone number, age, language, country of origin, player *nickname*, rating result.
- Automatically collected: Information recorded when you visit our website through cookies, when you install our app, or when you play our games. This information is used for statistical purposes, without personal identifiers. Examples of this type of information are location, device and IP data, web analytics information such as web page interactions, search history, gender, age. We also collect photos and footage of your experience in InBattle to share it with you, but you can always choose not to have this service.
- Collected from third parties: Information received from service providers, social networks and advertising partners, such as google analytics, Facebook Business or similar tools, in order to improve our services and marketing.

OUR PURPOSES FOR COLLECTING YOUR PERSONAL INFORMATION

- Our main purpose is to provide you with the service you are requesting, customize your experience and improve our services. This includes completing your booking and make sure we can contact you if needed to process your order, creating your account and profile, providing you with the services and information you request, Develop and improve our product and services, personalizing your experience, respond your enquiries or support requests.
- Your information may also be used for marketing and selling services, for personalizing our services and communications to provide you with information, news and promotional mails.
- Regarding your InBattle experience, your information will allow us to personalize your experience, keep your paying records, remember your preferences.
- And finally for security protocols, and for legal compliance.

SHARING YOUR DATA WITH THIRD PARTIES

To offer you the best experience, we will work with third parties that help us improving our services. For this purpose, we share your Personal Data with them. However, our privacy policy does not apply to companies that we do not own or control.

Some examples of third parties with whom we may share information are:

- **Service Providers** that help us doing business and providing our Services, such as IT services, communication, support and customer service, payment processors
- **Marketing and Advertising Partners** that help us providing you with information interesting for your profile. This includes the analytics of usage, web traffic, app usage, in order to improve our communication and our services.
- **InBattle Community**. As a part of the In Battle community, videos or photos from your ingame experience may be displayed and visible to other InBattle players.

LEGAL OBLIGATIONS

We may share any Personal Data that we collect with third parties in conjunction with any of the activities set forth under the following legal requirement:

- Fulfilling our legal obligations under applicable law, regulation, court order or other legal process, such as preventing, detecting and investigating security incidents and potentially illegal or prohibited activities.
- Protecting the rights, property or safety of you, InBattle VR or another party.
- Enforcing any agreements with you.
- Responding to claims that any posting or other content violates third-party rights.
- Resolving disputes.

BUSINESS TRANSFERS

If a third party assumes control of our business (in whole or in part), the Personal Data that we collect may be transferred to the new controller. Should this happen, we will make reasonable efforts to notify you before the change on privacy policy practices.

TRACKING TOOLS, ADVERTISING AND OPT-OUT

The Services use cookies and similar technologies such as pixel tags, web beacons, clear GIFs and JavaScript (collectively, "Cookies") to enable our servers to recognize your web browser, tell us how and when you visit and use our Services, analyze trends, learn about our user base and operate and improve our Services. Cookies are small pieces of data— usually text files – placed on your computer, tablet, phone or similar device when you use that device to access our Services. We may also supplement the information we collect from you with information received from third parties, including third parties that have placed their own Cookies on your device(s). Please note that because of our use of Cookies, the Services do not support "Do Not Track" requests sent from a browser at this time.

CONTROLS AND CHOICES

You can request access to a copy of your Personal Data storage in InBattle. You can also request us to update or delete it on your behalf, in which case we will need to verify your identity through personally identifiable information. We may need to retain a minimum amount of information for legal purposes.

Photos and Footage: If the service is available, your acceptance will be required to have an automatic recorded footage and photos of your experience best moments. This will be recorded and send to your email only; it will also be stored for 2 weeks in case you need us to resend. You can always choose no to use this service by no accepting during the booking process.

Communication: You will be required your acceptance to receive our news and promotional emails. You can always decide that you want to suspend them by unsubscribing. This does not apply to functional communications regarding your reservation, payment acceptance or core communications for the experience you are requesting.

Cookies: You can decide which Cookies to accept through your internet browser's settings. You can also block, manage, or delete Cookies that are already on your device. Please note that in some cases blocking or disabling cookies may reduce or affect the functionality of our services.

DATA SECURITY

We seek to protect your Personal Data from unauthorized access, use, disclosure, and modification using appropriate organizational, physical, and technical security measures. Please be aware that despite our best efforts to protect the security of your account and data that we hold in our records, no security measures are completely secure.

PERSONAL DATA OF CHILDREN

Our services are not directed to individuals under 14 (fourteen) years of age, therefore we do not knowingly request personal information from a child under 13 (thirteen) without parental consent. A minimum of non-identifiable information may be required in order to process the information and prepare the parental consent. All players will be required to show their ID card when accessing our facilities, in order to make sure they are over 13.

If the parent of a child under 13 believe they provided InBattle with information, they can contact us to verify and delete any information that may have been unknowingly provided to us.

LEGAL

We reserve the right to disclose your Personal Data as required by law and when we consider it necessary to protect our rights and/or comply with any legal process.

CHANGES TO THE PRIVACY POLICY

We reserve the right to modify this Privacy Policy from time to time, as part of our continuous improvement processes. Please review this policy every time you enter our website, make a booking or play one of our games. The date at the beginning of the document reflects when the policy was last updated.
